

Application Form 8b Commercial Operations involving Marine Mammals Shore-based viewing activities

- If the application is approved, it is deemed to form part of the permit which is issued and must be complied with accordingly. Your application, therefore, must be clear, complete and accurate.

The Department will process the application and issue a permit if it is satisfied that the application meets all the requirements for granting a permit under the Marine Mammals Protection Regulations 1992.

How groups of people will be managed in the vicinity of seals or sea lions in particular to manage noise and behaviour:

If wildlife are present on the beach the group is guided to view them by the staff so correct distances and

behaviours are maintained by clients and the group can be withdrawn if the Guide judges the animals require this behaviour

Behaviour around breeding colonies, nurseries and pups:

Groups will respect breeding animals and maintain suitable distances and withdraw if the Guide deems the animals are being disturbed. This area is mostly home to males. We will not target or pursue viewing of mothers that have retired into vegetated areas to rest, sleep, feed or suckle pups.

What other actions you will take to minimise disturbance of the marine mammals:

Avoid coming between them and the sea

Never attempt to touch them

Do not move suddenly near them or make loud noises

Do not leave rubbish

"Specific locations where contact with marine mammals is proposed" - you need to list any particular sites you will visit where marine mammals are known or expected to be encountered; e.g. Red Rocks, Ohau Stream waterfall, Point Kean, Barney's Island, Adele Island.
