#### F. Objection or submission

The specific parts of the application that this objection or submission relates to are:

Forest & Bird opposes to the 30year term sought as this is entirely inappropriate given the extensive work underway on the Milford Opportunities Project and pending review of the Fiordland National Park Management Plan.

My reasons for my objection or submission are:

The Milford Opportunities Project is tasked with determining what the future of Milford Sound should look like including how people travel to and from the place. This may include recommendations on reducing flights in and out of the place which have a negative impact on the ability of people to enjoy the natural quiet of the place and can impact on wildlife. This is of particular importance given the National Park and World Heritage Area status considerations.

Allowing a 30 year concession will limit the ability to change how the area is used and lock in an existing use for a future generation.

The application makes no mention of climate change or how the proposed activity (especially permanent fuel tank) could be impacted by rising sea levels and increased frequency of storms. The Department has recently released an updated Climate Change Adaptation Action Plan, which specifically highlights the risk climate change will pose to infrastructure such as is in this application. The decision makers need to have regard for this plan when considering the application.

Page 15 of the Climate Change Adaptation Action Plan outlines how it is intended to inform all levels of the Department's planning and decision making, including National Park Management Plans. As the Fiordland NPMP has not been reviewed since this has been in place, a shorter-term concession would be appropriate to allow for that review to take place and ensure the concession is properly assessed in light of it.

The outcomes that need to be addressed by this application are:

Give precise details, including the parts of the application you wish to have amended and the general nature of any conditions sought if the application is approved.

The term of the concession needs to be shorter. A term of six years would allow for the outcomes of the Milford Opportunities Project to come out and be incorporated into a new Fiordland National Park Management Plan. A fresh concession application could then be assessed under these new plans.

The application must consider the affects climate change is likely to have on the activity and the impact the activity will have on contributing to climate change. There is no doubt that rising seas and increased storms will continue to impact on operations at Milford Sound. Decision makers must have regard for the Climate Change Adaptation Action Plan when considering this proposal.
