Testimonial for Path New Zealand Limited – Proposed development in the Eglinton Valley, Fiordland National Park

Late last year I recharged my walking bug, completing the 800km Camino de Santiago from France to the other side of Spain. It was quite an adventure and left me keen to continue the exploration of our own special places of Aotearoa New Zealand, and to find different models that open these experiences to many more of our own as well as international visitors.

Serendipity! Abbe approached me about providing a testimonial for the model she has been leading the development of and I couldn't be more delighted to do so. What she is proposing gives more people people like me, for instance! - options that otherwise are too rarely available here at home, pushing us off instead, to walk and celebrate and spend in other countries.

dominated by his attempt to redress injustices to Ngai Tahu from land purchases earlier in the 19-century.

Abbe's great grandfather, Canon Hoani Parata, served in WWI, and is remembered for his service in parishes and the communities of Riverton, Gore and Queenstown. Her grandfather, Hoani Parata, was a respected Officer in WWII and became the first Maori Brigadier in the New Zealand Army. He went on to have a successful business career.

Abbe's mother, Penelope Parata Hutchins, has also been active within the community. She was appointed as the South Island representative on the Waitangi National Trust Board, has been a member of the Southland Conservation Board and was the Chair of Ka Mate Nga Kiore, responsible for eradicating rats from Taukehepa or Big South Cape Island, one of the titi or muttonbird islands off the coast of Stewart Island.

Our family takes our responsibilities to the community seriously. I have known Abbe, and her parents Penny and Bryan, for many years and she has a strong sense of her heritage and respect for the wider community.

Abbe serves New Zealand's interests in her professional life at national and international levels, where she is highly regarded. I am proud of her quiet work there, on behalf of our whanau. In contrast to these sometimes very rarefied circles she is also a keen tramper, outdoorsman, environmentalist and conservationist.

She has briefed me on this proposal and I am delighted to recommend her as exactly the sort of person that should be starting a new business in such a special area.
