A) Description of Activity: Please describe the proposed activity in detail,

The Whakatane Rowing Club would be utilised by rowing members to exercise in , to launch boats from outside it's premises for, single scullers, double scullers, quad scullers, and octi scullers. To do this the club needs unimpeded access from the club to the steps on the Whakatane River Bank at multiple times daily. They then need to launch small coach boats that are motorised to run behind or beside the rowing boats so that coaches can give training advice to the rowers. Once rowing is finished or training then the rowers need to have access to the steps to lift the boats from the water and take them on their shoulders back to the club boat shed to wash down outside and then dry them and store them away. Any maintenance to the boats like rigging and derigging is done outside the boatsheds and also loading of boats onto trailers so that they can be hauled to regatta's once regatta season starts usually October – March of each year.

Whakatane Rowing Club Incorporated is located, 80 Landing Road, Whakatane.

We intend to use the The Rowing Club building for;

Training rowers, housing rowing boats, coaching boats and all the oars and equipment that go along with rowing.

The top part of the club is a Gymnasium which has at least 12 Rowing Machines, weights & 6 exercise cycles upstairs. The upstairs boat shed houses at least 12 Rowing boats. The downstairs shed holds at least 16 larger rowing boats.

We also have 6am morning training for our School Rowers, who then shower and use the Kitchen for breakfast (Porridge, Cereal & Toast) before going off to school. We also have 3-5pm afternoon training for school rowers, and learn to row classes for adults as well. There are also Masters training rowers who can come in and use the club and boats at any time of the day.

The Club is also used for Committee Meetings once a month and Club functions.

Now and again the hall is hired out for functions or meetings by the general public.

Whether we intend to make any changes to the infrastructure is;

Firstly dependant upon obtaining a long term lease, as it would defeat the purpose of spending money on the current building if the lease period does not give the club sufficient time to recoup the intended outlay. Secondly dependant upon funds available and applications for grants and thirdly upon the support of our club members, and parents.

It is our intention to bring the premises up to a better standard and lower the maintenance costs of the building. There are always improvements and upgrades that can be made to buildings of a significant age. The toilet blocks could do with an overhaul and could be extended, the windows on the club could do with changing as they are the old wood frames to name a couple of wants. This

At the moment we would like to concentrate on obtaining a long term lease which will then place the club in a position to reassess our building requirements and what the club members would like to do.





The area we are applying for is larger than the Rowing Club Building Structure. In attachment 3b:C above the blue arrows depict the path the boats and oars are carried from the boat sheds to the water. The rowers carry boats and oars up the bank from the boat sheds on both sides of the club. Then over and down the bank to the river steps. The weight of the boats in some cases require up to 12 or more rowers to lift and manoeuvre over the hill. There has never been a safety issue in the past 50 years with the boats being carried down the slope onto the steps. The steps are used by the public as well and generally they give way when our rowers are accessing the river.


It is a necessary and integral part of carrying out the rowing club activity, to have clear access to and from the river steps to launch the boats. Evidence to support above claim shown in following photos
