The Rangitoto Island Historic Conservation Trust was founded as a Charitable trust in July 1997 and incorporated in the same year.

RIHCTs Mission Statement

"To conserve and interpret the historic Bach Communities on Rangitoto Island for the benefit of all New Zealanders."

The Objectives are:

Research and Interpretation: Collect, archive and make accessible to the public, oral histories, photographs, written documents, artefacts and other relevant materials which contribute to the historical record of the Bach's and the Bach Communities.

Membership: Promote general membership and participation in the Trust's activities.

Environment: Promote awareness of the special environment, flora, fauna, and geology of the Island and liaise with like-minded groups.

RIHCT Milestones and Achievements to date:

- Formation of the Trust in July 1997.
- Writing of a Business and Development Plan in October 1998.



Kia ora whanau and friends,

The Rangitoto Island Historic Conservation Trust (RIHCT) is applying for a 10 year concession to provide overnight accommodation in historic Baches on Rangitoto Island. The Trust would like input on this application from your perspective. We would like to know how the proposal may have an effect (good or bad) on your cultural interests and associations with the activities applied for in this application.

The Rangitoto Island Historic Conservation Trust was formed in 1997 and first signed a Concession Agreement with the Department of Conservation in 2010. Since formation the Trust has raised over two hundred thousand dollars and has given thousands of hours of volunteer time restoring, managing and interpreting the historic baches and their communities on Rangitoto Island, all of which remain Crown assets.

Background Experience of Applicant

The Trust has restored and operates a bach museum at Rangitoto Wharf which attracts approximately 3500 visitors each year. The restoration work undertaken by the Trust on this bach won a UNESCO Asia-Pacific Heritage Award competing against large projects including a palace in India, a performing arts centre in Hong Kong and a canal community in Thailand.

RIHCT have an existing concession for the "Sale of merchandise and food, guided walks, fishing competitions, provide visitor interpretation/experience from the museum at bach 38, guided walks around tracks (not including the summit) and running of events on Rangitoto Island scenic reserve."

Bach 114 and Bach 78 have been fully restored and Bach 103 (Flounder Inn) is in the process of restoration. All of this work is paid for and organised by the Trust.

Face to face meetings were requested by Fergs Kayaks and John Walsh from RIBCA. RIBCA were concerned about fire, noise and potential harassment from Bookabach guests. The informal meeting at Johns bach was requested in advance of their email which formally records these concerns.

The meeting with Fergs Kayaks was positive and in support of the overnight accommodation concession. Ways of working together to promote overnight kayaking opportunities were discussed.

The Chair of RIHCT, Elizabeth Andrew, was approached by Belinda Vernon and Biddy Winstone of the Motutapu Trust on a return trip on Fullers Ferry where both offered their support or the concession application. This has been accepted by the Trust as evidence that MRT have received and discussed the concession application.

Consultation Conclusion

After consulting with a large number of stakeholders the Trust received 5 emails in support of the application. Concerns raised during the consultation period were assessed by RIHCT and resulted in following modifications to the draft application:

 Reduction of the intended 10 year term to 5 years with the right of renewal for a further 5 years if successful. Fire, noise and harassment issues raised by RIBCA have been added to and addressed in the Environmental Impact Assessment (EIA).

Overnight guests will get a personalised welcome and induction to the bach. The onsite bach managers will warn visitors of various heath and safety issues. If the baches were open to all members of the public there would be concerns around:

- Drinking water
- LPG
- Electrocution
- Fire
- Vandalism & theft

Exclusive possession is necessary to protect physical security of the heritage asset

The three bach communities on Rangitoto Island are registered as Historic Areas by the Heritage New Zealand Pouhere Taonga. The Bookabach process ensures that overnight visitors are aware of the buildings heritage values. The BookaBach guest details are recorded and each visitor takes ownership/responsibility for the building while they are on site.

Exclusive possession is necessary for the competent operation of the activity

The overnight bach booking opportunity on Rangitoto will allow sole use of historically significant assets. This exclusive occupation will allow visitors the opportunity to step back in time to reminisce about life on Rangitoto in the 1930/50s. The overnight activity is a form of interactive interpretation which would not be possible if the buildings were left open for all to access.

To achieve the purpose of this concession, the Trust shall undertake the following management activities.


- a. Manage overnight accommodation in agreed baches, on Rangitoto Island Scenic Reserve, on a day-to-day basis;

Why RIHCT should be awarded this concession

The Rangitoto Island Historic Conservation Trust would like to perpetually restore vibrancy and life to Historic baches on Rangitoto Island in collaboration with the Department of Conservation (DOC) for the benefit of all New Zealanders. The Trusts' aspirations are to market and manage baches on Rangitoto Island to raise funds which will be reinvested into the Islands historic bach communities.

This will enable overnight opportunities for members of the public and return life and vibrancy to heritage fabric on Island.







Bookabach Pilot Summary - 3aE

The following information has been compiled to give an overview of the Bookabach pilot.

The 5 month trial period was granted by the Department of Conservation, from the 1st of December to the 30th of April 2018, to see whether the Overnight Rangitoto venture would be successful. The pilot period has been immensely popular receiving 100% positive feedback on the Bookabach website (See below for a selection of the comments). Keith Gell the Auckland Area Operations manager has given the Trust and the bach managers - Motu Whare Ltd approval to continue after the pilot ends while a formal concession is applied for.

287 people experienced Overnight Rangitoto in baches at Islington Bay over 6 months between December 1st and 28th May 2018. Of the 287 guests 227 were adults and 60 were children.

We feel that RIHCT is providing an amazing, relaxed overnight opportunity that inspires recreational adventures. The opportunity to stay on the Island has enriched the baches and the lives of those visiting Rangitoto by encouraging enjoyable, fun excursions and unforgettable memories.

The Trust would like to move forward as soon as possible with being able to offer the Tennis Pavilion and other baches on the Bookabach facility. We feel there is a synergy here for larger groups using the baches and Tennis Pavilion together for special events.

Media Promotions

The baches have appealed to a number of clients who have provided further media opportunities. First Scene is fully involved in promoting the baches though their regular newsletters and we have been offered the opportunity to be involved in a major fundraiser in April.

Another client put the Trust in contact with Jessie Mulligan on National Radio where a 5 minute live talkback was undertaken. Bookings were seen immediately after this segment aired.

Rachel Hunter visited bach 114 on the 2nd of March 2018 and mentions this trip on her Instagram and Facebook feeds.





Thank you for the application.

My email serves to summarize our formal response.

We enjoy a great relationship with Elizabeth and the team.

Initially the concerns we have are more related to the Crown role in this.

At one time recently, there was talk during negotiations with the Crown that these bachs would return to iwi but the conversation died of natural causes.

That aside, the work the group does is strongly supported by ourselves and one of our iwi Board members has already begun hiring the bach (Reuben Kirkwood).

Although we support the groups work, the time period is of interest in so far as, we would prefer a 5 year period of renewal as opposed to a 10 year period.

This is because of our legal case against DoC in the Supreme Court whereby DoC concession approvals to both islands only last 5 years for other concessionaires.

Is this a concern to you?

If not, then if you could recast the period of concession to 5 years we will support formally immediately.

You can of course persist with the 10 year period you originally sought but this may not achieve our support as a 5 year period would.

Out other issue is how the management of this relies upon accommodation on Motutapu ie: kitchen and bathroom facilities which DoC have brought to our attention. This cannot be sustainable unless DoC free up a complete house for this to continue but will leave this matter to you both to sort.

As you know, Nga Tai treaty settlement now has a date for the final reading, 28 June, from which the settlement becomes an Act of Parliament. This will then mean, Ngai Tai is the only exclusive iwi to Motutapu of which Ngai Tai has some significant plans particularly at Hukunui or Pa Paddock.

On that note, could you reply with revised time period or not and how it is your management proposes to maintain the access for kitchen and bathroom facilities on Motutapu.

The Rangitoto Island Bach Community Association wishes to ensure that people renting baches from RIHCT are made aware that:

-the danger of fire is ever-present on Rangitoto and could affect not only the rented bach but also neighbouring baches (which are uninsurable) as well as the island's vegetation. The absence of a fire brigade and readily accessible pressurised water heightens this risk. The risk comes from bonfires, candles, fireworks and solid fuel bbqs.

-loud music and noisy parties are not part of the island culture.

-bach renters should respect the rights of the occupiers of the baches under family guardianship.





Rangitoto Islands now form the basis of a programme of teaching island geographies.

For the last two years, my field teaching for a postgraduate course ('Land, Place and Culture') has been enhanced through being hosted by a representative of the RIHCT who has offered a guided tour of significant historic sites on the island including the Bach 38 Museum. The depth of commitment to Rangitoto's built heritage on the part of RIHCT has impressed me, as has their commitment to the co-existence of biodiversity and human history. They are also clearly committed to fostering low-impact visitor experience of the island.

While a fleeting day-visit to any island is illuminating, staying overnight on an island characterised by biodiversity and historic heritage takes the visitor experience to another level. I have therefore been impressed to see RIHCT's commitment to developing rental accommodation options among the suite of restored baches. This commitment both enhances visitor experience and provides a needed income stream to fund further bach restoration activity. I have been impressed by the safeguards around the opening of these two as accommodation options. These safeguards include the presence nearby of permanent residents Trust members who can offer qualified oversight,
