Thank you for your Official Information Act request to the Department of Conservation, received on 03 August 2021 in which you asked for:

*'... any and all information, correspondence relating to the granting of permits to Te Waka Kotahi for the killing or catching of wildlife in the Mount Messenger Bypass project I also request all information, correspondence relating to permits issued under sections 53 or 54 of the Wildlife Act 1953 to Te Waka Kotahi in northland
Kind Regards Joseph.'*

On 18 August 2021 we extended the timeframe to meet your request to 26 October 2021 due to the large quantity of information sought and consultation required to provide an accurate and considered response.

Your questions and our responses are listed below:

1. 'Any and all information, correspondence relating to the granting of permits to Te Waka Kotahi for the killing or catching of wildlife in the Mount Messenger Bypass project.'
 - a. Information held by the Department concerned with pending Wildlife Act Authority application 91389-FAU is provided as part of our response. Information supplied includes correspondence and other documentation associated with the authority's continued processing. Please note that the Department is restricted in what it can release on this matter due to the status of the application which is still pending and under consideration, ie. no decision has been made.

There are several other activities proposed by Te Waka Kotahi within Mount Messenger which required approval under the Wildlife Act 1953. These authorities are:

- 53708-FAU
- 65458-FAU
- 94669-FAU

- 63449-FAU

Information associated with the processing and approval of these authorities is within scope of our response. Correspondence, supporting documentation and file notes concerning this matter are attached. For a breakdown of information provided please see 'Table 1 – schedule of documents' below.

2. 'All information, correspondence relating to permits issued under sections 53 or 54 of the Wildlife Act 1953 to Te Waka Kotahi in northland.'

a. Information held by the Department relating to applications lodged by Waka Kotahi for activities in Northland which require approval under the Wildlife Act 1953 is provided as part of this response. Authorities granted to Waka Kotahi in Northland which meet your request include:

- advice subject to legal privilege, under section 9(2)(h) - to maintain legal professional privilege,
- commercially sensitive information, under section 9(2)(b)(ii) – to protect the commercial position of the person who supplied the information, or who is the subject of the information,
- confidential information, under section 9(2)(j) – to enable the Crown to negotiate without disadvantage or prejudice.
- free and frank opinion, under section 9(2)(g)(i) and protection from improper pressure or harassment, under section 9(2)(g)(ii) – to maintain the effective conduct of public affairs,
- that the information requested cannot be made available without substantial collation or research (section 18(f)).
