

Summary of Abel Tasman Foreshore Scenic Reserve Management Plan Provisions for Water Taxi Activity

<p>Can drop off/pick up private landowners, public visitors, non-motorised watercraft and goods/ hire equipment between 7am and 6pm.</p> <p>Only vessels with on-board toilets and sewage holding tanks can land at the western Anchorage CAP# (if toilet facilities are built at this location then all vessels can land here).</p> <p>Maximum of 500 person movements for public visitors (combined total for all concessionaires) per day at Medlands Bay and Bark Bay/Wairima (combined); Tonga Quarry¹ and Onetahuti (combined); Awaroa Beach and Sawpit Point (combined); and Totaranui.</p> <p>Maximum of 450 person movements for public visitors (combined total for all concessionaires) per day at Anchorage.</p> <p>Can land at an alternative location within the same bay where there is the need to protect the safety of clients in extreme sea conditions.</p>	<p>Can drop off/pick up private landowners (and their visitors and goods) at any time.</p> <p>Can drop off a maximum of 300 public visitors (combined total for all concessionaires) per day at Torrent Bay between 9am and 12pm (midday) only.</p> <p>Can drop off/pick up public visitors up to a maximum of 500 person movements (combined total for all concessionaires) per day, plus non-motorised watercraft, at Awaroa Beach and Sawpit Point (combined) between 7am and 6pm.</p>	<p>Can drop off/pick up private landowners (and their visitors and goods) at any location at any time. Landings as close as possible to the landowner's property.</p> <p>No entry into vessel exclusion zone at Venture Creek, Awaroa, from the first weekend prior to Christmas until the first Monday after Waitangi Day.</p> <p>No other landings allowed.</p>	<p>Can drop off/pick up private landowners (and their visitors and goods) at any time, provided the vessel lands as close to the bach or property as possible.</p> <p>Can drop off/pick up public visitors (walkers only) up to a maximum of 200 person movements (combined total for all concessionaires) per day at Apple Tree Bay/Whenuakura between 7am and 6pm, provided the vessel lands as close as possible to the toilet.</p> <p>One existing operator can drop off/pick up commercially guided walkers at Stilwell Bay, and drop off only at Coquille Bay, up to a maximum of 40 times per year between 7am and 6pm.</p> <p>Can drop off/pick up public visitors undertaking, and non-motorised watercraft used for, commercially guided trips that start or finish at Observation Beach bays, between 9.30am and 4pm.</p> <p>Can pick up non-motorised watercraft from Observation Beach bays for safety reasons (where clients who are part of a commercially guided group are unable to travel any further along the coastline due to weather and sea conditions).</p> <p>No other landings allowed.</p>	<p>No landings</p>

¹ Use of a designated landing area at Tonga Quarry by water taxis is being trialled for a limited period of time. The end of this trial period will be determined following the full review and approval of the management plan (see Map 2D and Section 6.1.3.3 of the plan for further details).
