## LETTER FROM THE CHAIR

#### 1. INTRODUCTION

This is the 30th Northland Conservation Board Annual Report. Section 6(O) of the Conservation Act requires conservation boards to provide the New Zealand Conservation Authority (Authority) with an annual report as soon as practical after 30 June each year. In recognition of this requirement, the Northland Conservation Board (Board) submits this annual report.

Conservation boards are independent advisory bodies established by statute. They represent the community and offer interaction between communities and the Department of Conservation (**Department**) within their area of Jurisdiction.

Conservation board members are appointed by the Minister of Conservation under section 6(P) of the Conservation Act 1987 (Act). Board functions are outlined in section 6(M), and the powers, which enable the conservation boards to carry out those functions, are under 6(N) of the Act. The board has several statutory roles under various Acts, including:

- the recommendation of the Northland Conservation Management Strategy (CMS) to the Authority for approval
- advising the Department and the Authority on how conservation management strategies and plans will be put into practice
- reporting on the implementation of the CMS
- the recommendation of national park management plans to the Authority for approval
- advising the Department and Authority on conservation matters, and proposed changes to the status of the land of national and international significance
- liaising with the regional Fish and Game Council on conservation matters
- carrying out other powers delegated by the Minister of Conservation, the Conservation Act or any other Act.

Conservation boards also have several functions under section 30 of the National Parks Act 1980. These functions include recommending the review or amendment of national park management plans and recommending approval of these plans by the Authority.

#### 2. ROHE

Te Rūnanga Papa Atawhai o Te Tai Tokerau/Northland Conservation Board's area of Jurisdiction covers 3,009,950.76 hectares. It takes in the top of the North Island and is located north of a line from the Kaipara Harbour mouth in the west across to the Mangawhai Harbour in the east. It includes groups of offshore islands, Taranga, Marotiri and Tūturu / The Hen and Chickens and Tawhitirahi and Aorangi / Poor Knights. Although the Te Hiku o Te Ika Conservation Board sits above it, Te Rūnanga Papa Atawhai o Te Tai Tokerau/Northland Conservation Board still manages the coastal area around Te Hiku's rohe. The area also extends out to the 12-nautical mile limit with respect to coastal and marine issues and out to the 200-nautical mile limit with respect to protected species.

#### 2.1 Conservation features of the area

The main features of Public Conservation Land and Waters within the board's boundaries are:

- 1 Ecological Area 33.54 ha
- 176 Scenic Reserves 18,643.84 ha
- 18 Historic Reserves 195.18 ha
- 43 Recreation Reserves 1,674.76 ha
- 179 Stewardship Areas 18,877.55 ha
- 324 Marginal Strips 2,013.6 ha
- 1 Specially Protected Area 547.6 ha
- 2 Marine Reserves 2,161.8 ha
- 1 Sanctuary to protect Marine Mammals 255,977.23 ha

#### Features of note include:

- The 16 harbours, numerous bays, inlets, and islands on the 3000km long coastline are a primary attraction for residents and visitors to the region.
- The largest area of relatively unmodified sandhills, dune lands and wetlands (Pouto Peninsula).
- The largest Manawa/Mangrove "Avicennia Marina" Forest (Rangaunu Harbour).
- One of the most biologically rich harbours (Parengarenga Harbour) in Aotearoa.
- Kaipara Harbour is a dominant and unifying feature, as its catchment drains almost the entire southern half of the region as well as linking with the adjacent Auckland region.
- Waipoua Forest (12,291.69 ha).
- A high number of threatened and at-risk endemic invertebrates, including land snails and insects, often with locally restricted distributions.
- Home to over half of Aotearoa's vascular plant species. Of the 804 species that are only found in Aotearoa, 152 species only occur in Northland.
- Predator free islands.
- Diverse and unique freshwater and marine habitats.
- Te Hokianga-nui-a-Kupe The place of Kupenuku's great return and the birthplace of Aotearoa.
- Waitangi Where Te Tiriti o Waitangi (the Treaty of Waitangi) was signed in 1840.

#### 2.2 Conservation issues in the area

Approximately 2.79% of all public conservation land in Aotearoa lies within Te Runanga Papa Atawhai O Te Tai Tokerau's Area of Jurisdiction. The large number of issues that are of interest to the board include:

## 3. FUNCTIONS

## 3.1 Board functions under section 6M of the Conservation Act 1987

The functions of the board are:

- 1) To recommend the approval by the Authority of conservation management strategies, and the review and amendment of such strategies, under the relevant enactments.
- 2) To approve conservation management plans and the review and amendment of such plans under the relevant enactments.
- 3) To advise the Authority and the Director-General on the implementation of conservation management strategies and conservation management plans for the area within the jurisdiction of the board.
- 4) To advise the Authority or the Director-General on any proposed change of status or classification of any area of national or international importance.
- 5) To advise the Authority or the Director-General on any other conservation matter relating to any area with the Jurisdiction of the Board.
- 6) To liaise with any Fish and Game Council on matters within the jurisdiction of the board.
- 7) To exercise such powers and functions as may be delegated to it by the Minister under this Act or any other Act.

#### 3.2 Board power under section 6N of the Conservation Act 1987

- 1) Every conservation board shall have all such powers as are reasonably necessary or expedient to enable it to carry out its functions.
- 2) Without limiting the generality of subsection (1), each conservation board may
  - i. Advocate its interests at any public forum or in any statutory planning process; and
  - ii. Appoint committees of members and other suitable persons, and delegate to them functions and powers.
- 3) The power conferred by subsection (2)(a) shall include the right to appear before courts and tribunals in Aotearoa and be heard on matters affecting or relating to the board's functions.

## 3.3 Board functions under section 30 of the National Parks Act 1980

There are currently no National Parks within Te Rūnanga Papa Atawhai O Te Tai Tokerau's area of Jurisdiction.

### 4. MEMBERSHIP

The Minister of Conservation appoints Board members under section 6P of the Conservation Act 1987. The appointment process ensures that a range of perspectives, life experiences, and knowledge contribute to the advice provided and decisions made by the board.

Board members are appointed for 3-year terms and may be re-appointed unless they are appointed in replacement of a prior member's term.

There were 7 Board members for the reporting year. Tania McInnes was elected Chairperson (12 June 2020), and Lydia Draper was elected Deputy Chairperson (11 September 2020).

#### 5.2 Field trips and site inspections

Field trips are an excellent opportunity for Board members to become more aware of conservation issues within their region.



O 22 October 2020 - Field trip to the Ruakākā Wildlife Refuge, meeting with the Bream Bay Coastal Care Trust, Patuharakeke hapū and Ruakākā Residents and Ratepayers, followed by a light lunch. The purpose was to view the impacts of mangrove removal and listen to concerns from community groups in the area.

2 December 2020 - Field trip to Ruapekapeka Pa, guided by Tohe Ashby (Rongoā Practioner) and his trainees. Ruapekapeka is Aotearoa's best-preserved land battlefield. The ditch and bank defences, a carronade used by Chief Kawiti and the earthen defences of the British forward position are still visible. Tohe also shared his wisdom on Kauri Ora and Rongoā well-being.





o 15 April 2021 - Members of the Hokianga community gathered together in the morning to share their hopes and fears for the area with the board. Dallas King presented on behalf of Te Mauri o Te Wai, who are concerned with wastewater being discharged into the Hokianga Harbour; Roger Brand represented Opononi Omapere Ratepayers and Residents Association and spoke of issues regarding 'Three Waters' within the Hokianga catchment. His presentation aligned with what Te Mauri o Te Wai highlighted; Charlie Nathan of Te Mahurehure presented about the kokako recovery programme he is working on in the Waima Forest; Olly Knox spoke about trapping and weed control in the south Hokianga area. A clear message was the need for protection of the well-being of the Harbour. A shared lunch followed. The afternoon was spent under the majestic Tane Mahuta, hosted by Te

Roroa, as they shared their mahi in conservation. As an outcome of this day, the board has now made the health of the Hokianga Harbour one of our main priorities.

15 June 2021 - Project Island Song - Floating Classroom - Ipipiri - Project Island Song is the Bay of Islands' wildlife sanctuary. The seven main islands in the eastern Bay of Islands have been pest mammal free since 2009, and the natural ecosystems are being restored. Project Island Song's education programme (Floating Classroom) is a crucial part of the project, providing a no-cost, hands-on experience for local schools enabling tamariki the opportunity to experience Ipipiri. Students learn about the restoration of this ecosystem and the crucial part they play as future kaitiaki.

The board was invited to join Te Kura Kaupapa Māori o Taumarere when they visited the Floating Classroom. We felt privileged to share the experience and know such a program is nurturing the seeds of the future. We were also impressed with the quality of education the students received and the pre and post support you and Shane do to in-bed the learning, brilliant work.

Predator Free Whangārei is a collaborative five-year project that builds on years of dedicated and successful community predator control in the Whangārei area.

This project brings together community, conservation groups, landowners, iwi/hapū and partners Kiwi Coast, Whangārei District Council, Department of Conservation and Northland Regional Council.

#### Special Liaison Events:

17/18 May 2021 – Auckland Conservation Board / Aotea Hui: Attended by Lydia Draper (Deputy Chair) as board liaison representative on behalf of the board. While visiting Aotea for the Auckland Conservation Board hui, we were blessed to be welcomed into Okiwi School, a primary school with about 30 children from years 1 to 8. "We speak English and Te Reo Maori at our school. Every day someone volunteers to be the kai whakahaere for our whakapuare and other tauira volunteer to be kaiwaiata, kaikarakia, kaihuarere and kaikorero. Even our five-year-olds can mihi to us and our manuhiri for the day, and we all take turns at everything. We usually work as

tuakana / teina buddies so that we tautoko and awhi the younger tamariki. We have mahi kainga every night and we share our rataka tuhituhi in the morning."

The visit to Okiwi School was uplifting and so inspiring! The tamariki proudly welcomed us into their kura and talked us through the many activities they do to help the taiao and moana. They manage their own pest control (checking and clearing traps), keep chickens (and eat the eggs), grow gardens, plant native trees (to feed the birds) and do beach clean ups. Their beautiful grounds were flourishing under their devoted love and care. I had misty eyes many times during our short visit!



The Authority has a liaison member with the board to facilitate communication. The Authority liaison attends Board meetings and reports to the full Authority on matters raised. The Authority's liaison for the 2020/2021 year was:

#### 8.3 Submissions

The board did not make any submissions during the 2020-2021 financial year.

#### 8.4 Community advocacy and involvement

The board believes that working with conservation organisations and members of the public is very important. Board Meetings were held in different parts of the Northland region and advertised not fewer than five days before the meeting, inviting the public to attend.

Members of the public attended the Public Forum at several of the year's meetings, and a range of issues were raised. The board appreciated their input and efforts to participate in the discussions and responded by letter to questions asked or concerns presented.

Public forum issues raised were:

 3 December 2020 – Sharon Greig and Jo Baguley – (Atlas Legal – Representing Lucklaw Farms Limited) – Puwheke Beach – Vehicle Access to the Beach.

The board has a practice of inviting representatives from community organisations to present at each meeting. Speakers this year have represented:

- o 15 April 2021 Te Mauri o Te Wai (Dallas King) Presented on their concern regarding wastewater being discharged into the Hokianga Harbour.
- o 15 April 2021 Opononi Omapere Ratepayers and Residents Association (Roger Brand) Spoke of 'Three Waters' issues within the Hokianga catchment. His presentation aligned with what Te Mauri o Te Wai highlighted.

- o 15 April 2021 Te Mahurehure (Charlie Nathan) Presented about the kokako recovery programme he is working on in the Waima Forest. (Olly Knox) Spoke about trapping and weed control in the south Hokianga area.
- o 16 April 2021 Willie Wright (Programme Manager Integrated Kaipara Harbour Management Group (IKHMG)) Kaipara Moana Remediation Project Presentation.

These were predominantly voluntary groups carrying out vast amounts of conservation work within the community. The board recognises and appreciates volunteers and thanks them for the work done in this area.

### 8.5 Community visibility

The board maintains a presence on the Department's website and via the quarterly Conservation Board Newsletter.

The board also enjoys continued growth in popularity with their social media presence on Facebook. Te Rūnanga Papa Atawhai o Te Tai Tokerau has a Facebook page with over 300 followers. We share content with a strong focus on Te Tai Tokerau and te taiao.

o 2020/2021 - The New Zealand Fairy Tern Charitable Trust - Our Board is proud to have provided funding for the "Welcome to NZ Fairy Tern Territory" signage in Mangawhai and Waipu (photos attached), where breeding areas are located. Designed by local Mangawhai artist Anna Wild, it is hoped the signs will bring awareness to our most endangered and rarest endemic bird. The artwork of the fairy tern is being reproduced on t-shirts this year that will be sold by the Trust. All proceeds will go into the fantastic work that the Trust does in supporting the conservation of this rare and precious shorebird. They work directly and in partnership with the Department of Conservation and NZ Forest & Bird to improve breeding success and adult survival.



Early in 2021, the Parking Area on Pātaua Island was occupied over a settlement dispute with the Whangārei District Council and the Department of Conservation. The mautohe welcomed hundreds of people onto the Pa to spread awareness of the wrongdoings to the hapu and to occupy the whenua until a resolution was met. Kaitiaki occupied the land for 145 days (holding multiple wananga during this time) and scaled down to fewer kaitiaki to carry out the works. Edward Ashby visited in support of a Wananga about Kauri Ora. Julie Riggir attended in response to an invitation to Te Rūnanga Papa Atawhai o Te Tai Tokerau from the Kaitiaki at Pātaua.

The Pātaua people are now working to support hapu with wetlands recreation and reconnection of the Pātaua and Taiharuru estuaries. They plan to establish nurseries and to support the emerging Hapu Resource Management Field Centre.
